HK Authorities acted with disrespect, exhibited lack of good judgement in the manner they treated another RP official - Gordon

Senator Richard J. Gordon yesterday said Hong Kong authorities acted with disrespect and exhibited lack of good judgment in the manner they treated former Foreign Affairs Secretary Albert del Rosario, who was detained for hours at the Hong Kong airport for undisclosed reasons.


Gordon pointed out that with Del Rosario's pronouncements, too, on the abandonment of our fishermen by Chinese crewmen, such action cannot be interpreted as no less than intimidation if not outright harassment of a law abiding and internationally respected personality as the former DFA chief.

"Hong Kong authorities acted with disrespect and exhibited lack of good judgment. The maintenance of good and friendly relations, bilateral or multilateral, state to state, people to people, is a main objective of every government," he said.

The senator pointed out that this is the second time in one month that a Filipino official had been detained for hours at the Hong Kong airport. Last May 21, former Ombudsman Morales experienced the same when she and her family visited Hong Kong. Although Morales was eventually allowed to enter Hong Kong, she decided not to push through with the trip.

Del Rosario and Morales sued Xi before the ICC for crimes against humanity over Beijing's activities in the South China

The relevant ranking Chinese officials should take heed that we cannot change geography, that the Philippines and China are close neighbors. And have had a long history of friendly relations that should not be imperiled by mindless action such as in the del Rosario and Carpio-Morales treatment by HK authorities and the West Philippine Sea," Gordon said.

The sport of sailing is growing exponentially. In the past several months, private companies, organizations, government agencies, and even individuals have come together to support one of the biggest campaigns in the sport of sailing in the Philippines. We have companies and individuals who have shared their expertise and services in helping the club fulfill its goal to promote the sport particularly here in Subic Bay.

Spain, Great Britain, Japan, and the United States.

"Subic Bay has one of the highest concentrations of historic ship, aircraft and vehicle wrecks within sports-diving range in the world" according to Andy Davis, Scuba Tech Philippines.

Bobby Orillaneda, Museum Researcher at the National Museum of the Philippines, presented images of several underwater and historical artifacts that represent the cultural heritage of the Filipino people including those found 10 nautical miles off the shores in Sta. Cruz, Zambales in March 2001. Sunken treasures such as coins, urns, cooking woks, and porcelain were dated coming from 1488 to 1505 CF.

PH-Japan relations grow stronger

CLARK FREEPORT, Pampanga —The relationship between the Philippines and Japan proved to be growing stronger and deeper with the two countries agreeing on further

Finance Secretary Carlos Domin-guez said the 8th High Level Meeting of the Philippines-Japan Joint Committee on Infrastructure Development and Economic Cooperation held Tuesday at the Marriott Clark Hotel here was extensive and fruitful as both countries favored to maintain close coordination in resolving pending issues and revisiting certain procedures in order to fast-track the big-ticket projects of the Duterte admin-

istration.

"Our discussions covered broad areas of Philippines-Japan sectoral cooperation including regional development, information and communications technology, energy, environment, public safety, disaster prevention, and peace building initiatives in Mindanao. Both sides also discussed the strategy for future cooperation and considering the Philippines will soon graduate to upper middle-income country status by end of this year or in 2020," Dominguez said.

He said the two countries will also work towards signing a supplemental loan for the ongoing Davao City Bypass Construction Project within this year and three more loan accords for the New Mactan Bridge Construction Project in Cebu, the second phase of the Metro Manila Priority Bridges Seismic Improvement Project, and second tranche for the first phase of the Metro Manila Subway Project.

Also, he said a review progress of

nila Subway Project.

Also, he said a review progress of the Philippines Railway Project that will be rolled out in cooperation with Japan was tackled to accelerate implementation and to

address all the challenges.

Meanwhile, Dominguez said the conduct of feasibility studies by JICA for the Dalton Pass East Alignment alternative road project and circumferential road 3 missing link project will be done later this year.

"Japan affirmed its commitment to provide additional assistance for the rehabil-

itation and reconstruction of the most affected areas in Marawi City," he added.

The event was highlighted by the signing of a loan agreement amounting to USD202.02 million for the Road Network Development Project (RNDP) in conflict-affected areas in Mindaga ed areas in Mindanao.

The agreement was signed by Secre-

tary Dominguez on behalf of the Philippines and Japan International Cooperation Agency (JICA) Senior Vice President Yasushi Tanaka on behalf of the Japanese government. The project involves the construc-

tion and improvement of some 176.6 kilometers (km) of access roads that include 19.8 km of the Marawi Ring Road and 23 km of the Marawi Trans-Central Road.

The Japanese government is known to be the largest donor for the rehabilitation

of war-torn Marawi City.

"We thank Dr. Hiroto Izumi, Special
Adviser to Prime Minister Abe, for his keen
interest in seeing the speedy completion of the cooperation projects. We are looking forward for the 9th meeting of this committee which is scheduled on October this year," Dominguez said.

The eighth session of the high-level joint committee since it was first convened in March 2017 was part of the Duterte administration's efforts to fast-track the rollout of its

75 big-ticket projects under the President's signature initiative "Build, Build, Build".

Dominguez said nine other loan agreements with Japan were signed between October 2016 and January 2019 with a combined amount of JPY398.82 billion (about USD3.63 billion or PHP189.92 billion).

These are intended for the follow-

These are intended for the following projects: Maritime Safety Capability Improvement Project for the Philippine Coast Guard (Phase II); Harnessing Agribusiness Opportunities through Robust and Vibrant Entrepreneurship Supportive of Peaceful Transformation (HARVEST); Cavite Industrial Area Flood Risk Management Project; Arterial Road Bypass Project (Phase III) in Bulacan; New Bohol Airport Construction and Sustainable Environment Protection Project (II);

tainable Environment Protection Project (II); Metro Rail Transit Line 3 Rehabilitation Project; Pasig-Marikina River Channel Improvement Project (Phase IV); North-South Commuter Railway Extension Project (1st tranche of loan); and Metro Manila Subway Project (Phase I), which is the single biggest venture under the "Build, Build, Build" program.

Likewise, Japan remains to be the No. 1 provider of Official Development Assistance (ODA) loans totaling USD6.13 billion (47.51 percent share of the total ODA loan), and the No. 5 provider of ODA grants amounting to USD106.76 M (4.45 percent share of the total ODA grants) as of December 2018, according to the latest data generated by NEDA last April 25. CLARK FREEPORT ZONE, Pampanga -- Bases Conversion and Development Authority (BCDA) recognized the support of the Japanese government to the Build Build Build infrastructure program of the Duterte administration

infrastructure program of the Duterte administration.

"This is one of the legacies that President Duterte will be leaving behind, the beginnings of the New Clark City and we have the Japanese government to thank a lot because they really have been supportive from the very beginning," BCDA President Vivencio Dizon told reporters at the conclusion of the 8th High Level Meeting of the Philippines-Japan Joint Committee on Infrastructure Development and Economic Cooperation held in Clark.

"Based on the discussions in the meeting, there will be more support coming to us. In fact, there's a joint venture between the BCDA and Japan Overseas International Network for transport and urban development," he added.

Talking about Clark which is one of

the centerpiece of the administration's infrastructure program, Dizon mentioned that it was turned over to the Philippine government in 1991 and it has taken more than three decades for the area to

more than three decades for the area to really develop.

"I think we usually forget that in Luzon where close of 60 percent of Filipinos reside there is only one metropolis, that is Metro Manila," he stressed.

"Past governments have been unable to develop regions and areas outside of Metro Manila as new centers of growth and that is why we included the development of Clark and Subic because their strategic nature becomes really the centerpiece not just of the Build Build Build but also future developments later on," he stated.

"With these, we really need a new metropolis to not just address the congestion of Metro Manila but also to spread growth outside," Dizon furthered. (PIA 3)

Should the Philippines achieve the target of increasing its present economic status by the end of the year or in 2020, it will no longer be qualified for the Japanese Special Terms for Economic Parameters of the Parameters of t ic Partnership Funding.

At present, there are 12 NEDA board-confirmed projects amounting to P1.6 trillion by the Japanese Government through the Japan International Cooperation Agency. (PIA 3)

Bataan fishermen want Recto Bank row settled

MARIVELES, Bataan -- Members of a big group of fishermen here on Tuesday expressed their desire for the Recto Bank row to be settled peacefully but asked that the affected 22 fishermen and the boat owner be provided with the appropriate assistance.

Dalisay Cruz, president of the Sisiman Fishing Association, said there was nothing wrong with President Rodrigo Duterte saying what happened was a small maritime incident that should not be blown out of proportion as every problem has a solu-

The ill-fated boat, F/B Gimber 1, sank on the night of June 9 after being hit by a Chinese vessel at Recto Bank in the West Philippine Sea. Vietnamese fishermen later rescued the boat's 22 crew members.

Tama po kayo Mr. President, hindi natin kailangan makipaglaban. Ang lahat ng problema may solusyon kung makukuha sa mahinahon, magandang usapan (You are right, Mr. President. There is no need to fight. All problems have solution if there would be a calm and sincere dialogue)," she

The association in Barangay Sisiman here, which Cruz heads, is composed of more than 50 big fishing boats and 700

fishermen.

Cruz said dialogue is the best solution before anyone contemplates on war as the Philippines is no match to the military power of the Chinese government.

"At kahit meron tayong gamit pan-digma, pinaka the best na solusyon – pag-us-apan muna bago pumunta sa tinatawag na digmaan. Mr. President, saludo ako sa mga sinasabi ninyo (Even though we have armaments, still the best solution is to talk first before we go to what they call as war. Mr. President, I salute you for what you are saying)," she said.

But as a boat owner, Cruz appealed to President Duterte to help the affected fishermen including in the repair of the damaged fishing vessel.

"Ipagawa ang kanilang panghanap-buhay nang hindi naman sila sumala sa oras dahil alam natin kung paano ang buhay ng isang mangingisda na doon sila humuhugot ng pampaaral, pagkain ng pamilya (Repair the fishermen's source of livelihood be-cause we know the life of a fisherman, that is where they source funds for their children's education and food for the family)," she said.

Norbing Gaga-a, 63, also a fishing boat owner, said the damaged fishing boat

should be immediately repaired so that the crews can continue earning a living.

"Talagang ganoon lang. Barko nagbabanggaan, eroplano man saka tren. Humingi na lang ng tulong. Kapag nagawa ang bangka, makakapaghanapbuhay ulit (Things like that happen. Ships collide, even airplanes and trains. Just ask for help. Once the boat was repaired, they can go fishing again)," he said. (PNA)

Bright future seen for PH power industry

The Chief Operating Officer of one of the country's largest electric power companies has cited the Electric Power Industry Reform Act (EPIRA) as having significantly driven the cost of power down, while increasing the country's capacity and improving services to customers.

Emmanuel V Rubio, who is also the

Emmanuel V. Rubio, who is also the incoming President and Chief Executive Officer of Aboitiz Power Corporation, said that based on data, EPIRA has succeeded in improving the power sector for the benefit of consumers.

proving the power sector for the benefit of consumers.

Rubio was a keynote speaker today (June 20, 2019) at the Davao Investment Conference (ICON) in Davao City.

"(The) Philippines may still have one of the most expensive power rates in Asia. That may be true for now, but the data show that prices in the Wholesale Electricity Spot Market (WESM) has a downward trajectory," Rubio said.

Average WESM prices in 2010 was around Php6.43 / kwh going down to Php3.28 / kwh in 2018.

"It is important to take into consideration that the power industry in other ASEAN countries is subsidized, hence the substantial difference between the electricity prices of countries with and without subsidies," he said.

"Are prices still high? Perhaps. But it is continuously decreasing. In fact, from 2011 to 2016, only government charges have increased while charges controlled by the private sector have sustained a downward trajectory."

Data have shown that primarily because of EPIRA, private investments in the power sector led to the growth in energy capacity by almost 60% from 13,380 MW in 2011 to 21,423 MW in 2016. The industry expects to generate 5,000 MW more by 2020.

Rubio said that while news always highlight instances when WESM prices are

Rubio said that while news always highlight instances when WESM prices are high, it fails to note that in 2018, more than 95% of the time, prices in the spot market have been way below Php5 and in some instances the prices went negative.

He said that in order for EPIRA to fully realize its potential, the government and other sector must encourage an atmosphere of true competition.

"We learn from situations like this that the country's nower sector is not with-

that the country's power sector is not with-out any challenges. But what we fail to real-ize and appreciate is how far we have come because of EPIRA," he said. "EPIRA is working. And only when

there is strong support both from the government and private sector can it realize its full potential and achieve its ultimate goal of making electricity sustainable and accessible to all Filipinos."

"Competition among players, better services, and better technologies in the power plant will definitely result in more efficient production and more value to customers."

EPIRA, he added, was also the reason Mindanao enjoys a surplus of energy supply today, showing a stark difference from the eight-hour power outages the island experienced only around four years ago.

"EPIRA is working and only when there is strong support both from the government and private sector can it realize its full potential and achieve its ultimate goal of making electricity sustainable and accessible to all Filipinos," said Rubio.

Rubio also expressed excitement over the full implementation of the WESM in Mindanao, something that has long faced challenges but which he believes will open up a world of possibilities for big customers as well as for power generators.

He said AboitizPower is in the best position to take advantage of WESM and serve the customers best, especially with the company's portfolio of baseload, hydro, and peaking power plants in Mindanao that give them the flexibility to tailor-fit solutions depending on their customers' needs.

With more companies entering the power sector, developing new technologies to create more capacities, Rubio said it is without a doubt that the future looks bright for the industry and, most importantly, for consumers.
